Accessibility Statement

Minerva Omega Group is committed to making **Ice-Tek** website accessible, in accordance with Italian Law no. 4 of January 9, 2004. This accessibility statement applies to the website www.ice-tek.it

Compliance Status

Partially compliant - This website is partially compliant with the requirements outlined in Appendix A of the UNI CEI EN 301549 standard due to the non-compliances listed below.

Non-accessible content

The following content is not accessible for the reasons described:

- Informative and header images lacking descriptive alt attributes (criterion 1.1.1 – WCAG 2.1 AA): On the main pages and within the "About Us" section, many images do not include meaningful alternative text, making the content inaccessible to users who are blind or visually impaired.
- Sliders and dynamic content not keyboard-navigable (criteria 2.1.1, 2.4.3, 2.4.7 – WCAG 2.1 AA): The tab order is inconsistent. Slider controls are not clearly accessible via keyboard, nor do they provide visible focus indicators.
- Missing "Skip to content" link (criterion 2.4.1 – WCAG 2.1 A): There is no mechanism to bypass repetitive headers or navigation menus, significantly increasing navigation time for users relying on assistive technologies.
- Decorative brand images missing alt text or using empty alt (criterion 1.1.1 – WCAG 2.1 AA): Logos or brand-related icons are either missing textual descriptions or use generic/empty alt attributes, providing no meaningful information to screen reader users.
- Contact form with inaccessible visual CAPTCHA (criteria 3.3.1, 3.3.2 – WCAG 2.1 AA): The form includes an image-based CAPTCHA ("Type the numbers you see") without text alternatives. It is unclear whether it can be completed using only the keyboard, creating a barrier for users with disabilities.
- Cookie banners and similar elements without visible focus or perceivable heading (criteria 1.4.3, 2.4.1 – WCAG 2.1 AA): Interactive elements such as cookie notices lack proper accessibility indicators like tabbable controls and visible focus cues, making them hard to detect or interact with using screen readers.

The above non-compliances are due to non-fulfillment of technical requirements mandated by the applicable legislation. In some cases, exceptions have been claimed due to disproportionate burden.
